- 1.0 Board and Committee Reports
- 1.1 President: Beatrice Trautman
- a. Member Chuck Danford is in hospice and has asked Bea to write a letter to establish a scholarship in his name. The amount provided may be enough for more than a one-show award and perhaps others would contribute enough to add to the fund.
- c. Amber will be backing up Shanthi for the rest of the year.
- d. Caroline Hanna was unanimously approved for Signature Membership.
- 1.2 VP and Director of Programs: Carol Newsom
- a. For March, Diane Fechenbach, long-time CWS member, will be doing a critique.
- b. In April, Kathleen Manzoni will present a demonstration. Attendees will be asked to wear masks for this meeting to protect Kathleen's health regardless of other policies.
- c. In May, a combination of short demos by several members will show special techniques.
- 1.3 Treasurer: Bobbie Ruh
- a. CWS taxes will now be prepared by D.C.Melton for the same fee as before (\$950). An extension was obtained due to the IRS not accepting electronic submittals at the time. Bea will sign the form to send the report in now.
- c. CWS has awarded a total of \$500 for 5 scholastic awards. 5 new memberships were paid for this year's dues totaling \$175. \$3,425 income is anticipated for the Randy Hale workshop. Profit for January was \$ 3,630.00 and Net Income was \$ 2,713.27.
- 3.4 Exhibition Director: Kathy Cranmer
- a. A new and acceptable contract with the City of Aurora has been worked out for a potential show in April and May of 2023.

3.6 Parliamentarian Director: - Jay Breese

Proposed Policy changes have been posted on the website. The Board can decide at the next meeting when to accept the changes. Jay suggested that we approve and update the rest of our policies first then let a future board consider where to go from there.

3.7 Workshop Director: - Sandy Day-Selbert

Randy Hale will present a workshop on April 20-22, with a potential \$2,500 profit since he is local and will have fewer expenses. Keiko Tanabe will lead a workshop on July 14-16. Rene Eisenbart will present a marbling workshop September 14-16 and Marbling Applied on September 21-22.

3.8 Website Director: - Shanthi Kumar

Shanthi will be busy with two trips for her son's wedding in India and will stay involved with the board for the remainder of the year then will step down. Everyone appreciated her work on the board.

- 3.9 Membership Director: Elaine Campbell
- a. Elaine would like to get the word out early about the dues increase in June. Bea will send a letter explaining the need to the members.
- b. 4 new members joined since last meeting.
- c. A new Directory Designer is needed for 2022-23.
- 3.10 Director At Large Suzanne Snider reminded everyone that her position allowed her to help out anyone else on the board.

MARCH 15, 2022 BOARD IN BRIEF

- 1.0 Board and Committee Reports
- 1.1 President: Beatrice Trautman
- a. It was determined that the Directory update was too large a job to be voluntary. Jay moved that the board pay Amber Williams \$300 for updating the Directory. Jeremy seconded the measure. Passed unanimously
- b. Bea noted that we now need a new person to produce the Collage.
- c. There is currently about \$900 that has been raised for the Danforth Award. Several options were considered since it appears there is more money than needed for a single award.
- d. Bea will be gone in April, so Carol will be in charge of the meeting.
- e. It was agreed to have the membership vote on increasing the dues from \$35 to \$45 per year starting this June. The dues have not changed for about 20 years but costs have risen. CWS dues are the lowest of any WFWS chapter.
- 1.2 VP and Director of Programs: Carol Newsom
- a. In April, Kathleen Lanzoni will present a demonstration. Attendees will be asked to wear masks for this meeting to protect Kathleen's health regardless of other policies.
- b. In May, a combination of short demos by several members will show special techniques. Bea will demonstrate salt techniques, Jay do colored fillets, Gene will use cellophane and Sandy will demonstrate the wonders of wax.

- a. CWS currently has 363 members. Everyone is asked to check their online information when they renew their membership by June.
- 1.10 Director At Large Suzanne will be sending thank you notes to contributors to the Danforth Award and will send the names of donors to Chuck's wife.
- 1.11 Director of Collage: Amber Williams
- a. The next edition is scheduled to come out in May.
- 2.0 New Business: Bea and Jay introduced a paper titled "Clarification of Compensation Related to Board Members and Officers". Due to a conflict between the Bylaws and Policies, there needs to be clarification about non-cash benefits received by Board Members.
- Jay moved and Amber seconded that we go forward with wording to clarify this issue based on the initially submitted information.

APRIL 19, 2022 BOARD IN BRIEF

- 1.1 Vice President: Carol Newsom
- a. Carol led the meeting because Beatrice was out of town.

Carol mentioned that Beatrice and she had completed the master prospectus language that can be used for all shows. There were just a few changes from the most recent prospectus.

Carol reported the recommended slate of candidates for the CWS Executive Board has been shuffled a bit. Shanthi Kumar will be leaving the position of Web Director after having done a tremendous job for several years. Amber will become Web Director, Jeremy will become Collage Editor Director, leaving the Secretary position open. Georgia Mucilli attended the meeting and has volunteered to be Secretary. The Board added her to the slate of recommended candidates for the upcoming election. Georgia has substantial experience being a Secretary for other organizations and responded to the call for help at our last meeting. Thank you, Georgia!

The Board was familiar with the current Treasurer's report and it expressed no questions or concerns about it.


1.3 Parliamentarian Director: - Jay Breese

Rene will do a workshop the following week called "Marbling Applied" teaching the many ways of incorporating marbling into paintings. Sandy has scheduled a 4-day workshop with Kathleen Conover. The dates are June 6th, 7th, 8th & 9th, 2023.
