

## BETSY DILLARD STROUD, AWS, NWS Juror's Statement

The following is reprinted in an effort to educate our members as to what Betsy looks at when choosing paintings for an exhibit –

Originality is at the core of all good art. I selected the show based on originality and other important criteria: visual impact; creative concepts; craftsmanship; and content. What is content? The content of your painting is its dialogue – the ideas you wish to express. To be a mere technician is not enough. Show me your heart in your work and I'll show you a prize winner.

In entering a show, I offer you this advice. First, always enter your most original and best work and second, in your painting, express your personal methods and symbols to convey your ideas. Go out on a limb with your painting!

Also, don't forget the importance of a good professional slide. I automatically dismissed some paintings because the photography was horrendous. Show only your image – no frames, feet or fingers allowed.

When anyone judges a show, the prize winners are chosen by one common denominator. Choice. What are the choices based upon? The life experiences, taste, and eye of the person selecting the show. Basically, it comes down to this. I select what appeals to me the most and combined with the criteria mentioned above, best expresses both concept and medium.

Congratulations to the prize winners and all the artists who entered the show. Part of being a professional artist is putting your work out there to see how it competes among your peers. To those who didn't make the show, remember that it is important to strive to be a better painter, no matter what your level. As the poet Robert Browning said, "A man's reach should exceed his grasp or what's a heaven for?"
