

Entering the 29th Annual WFWS Exhibition

Getting it Right!!

- Before you do anything else, sit down and read the Prospectus for the WFWS Show. Reading this entire document before hand will eliminate any mistakes
- 2. Then, read this entire article
- 3. Mark on your calendar the dates for delivery of slides.
- Gather together the following materials before you begin the process of submitting your slides.
 - a. The **Prospectus** for WFWS 29th Show.
 - b. A **black pen** that can be used to write on a slide.
 - c. The measurements of your painting and the measurements that include the mat size to the nearest inch.
 - d. Two envelopes
 - i. One addressed to Patricia Rucker.
 - ii. A second one stamped, addressed to you.
 - e. A plastic slide sleeve to hold your slide(s)
 - f. A check made out to Colorado Watercolor Society in the amount indicated in the prospectus.
- Looking at the information in the Prospectus, label your slide(s) as shown, making certain that you have figured the size of the mat to the nearest inch. Do not use stick on labels.
- Transfer the information from your slide(s) to the portion of the form marked KEEP THIS SLIDE FOR YOUR RECORDS.

- Fill out the Entry Form, making certain that the information is exactly the same as on the slides and your record.
- 8. Make certain that you sign the form at the bottom.
- Go through the CHECK LIST and make certain that you have done everything, put them in the envelope addressed to Patricia Rucker.
- 10.Mail so that it is received by November 15. You may also deliver it at the October Meeting, or to Patricia Rucker at Foothills Art Center.

IMPORTANT: The slide must not show more than the painted surface. That means no fingers, brick walls, mats, grass, etc. Do not handle the negative film without gloves. If you find it necessary to tape the edges of your image, you will need to narrow mylar tape, gloves to remove the film. Partially open the slide, use tweezers to remove, tape the film and replace. Make certain that the slide is completely closed. If the negative film falls out you will have to use another slide carrier.

You will know if you passed this test – I will not be calling you to come to Golden and fix your work. It is my hope that this article and the one by Nita Leland in the September issue will encourage you to enter your work. Good luck.
