# Membership news



# Did you know that CWS operates on an annual budget?

CWS has an annual budget that is made up in September (the beginning of our fiscal year). All committees should submit how much they are planning on spending for the coming year. Otherwise, the amount spent the previous year for that committee is what goes into the budget. Committees should try to keep their spending within that range. This budget money may or may not be used. It is not a checking account system where if you do not use the money it will carry over to the next year.

# The By-laws of the Colorado Watercolor Society state:

Article VII, Section 7.2. Budget. Each year, at the October meeting, or earlier meeting called for that purpose, the Executive Board shall approve a budget. The Executive Board shall consider any request for funds not covered in the

budget that exceed \$250.00. The President and Treasurer may approve or reject any such request that is under \$250.00. ■

# A BRIEF HISTORY OF WESTERN FEDERATION OF WATERCOLOR SOCIETIES

The Western Federation of Watercolor Societies encourages and recognizes artistic excellence through competitions and increases the visibility of watercolor as an artistic medium through annual exhibitions. The purpose as stated in the "By-Laws" of the WFWS "will be to stimulate interest in watermedia, exchange educational information and to present annual exhibitions." The New Mexico Watercolor Society through the foresight and work of Dr. David Gale (1915 - 1980) founded the Western Federation of Watercolor Societies and the first annual exhibition was held in 1976 at the Museum of Albuquerque with six of the societies. Each society hosts a WFWS Annual Show on a rotating basis. Today, WFWS includes over 5000 members in 10 regional societies.

During 2007, the Colorado Watercolor Society will co-host the 32<sup>nd</sup> Annual WFWS at the Arvada Center for the Arts and Humanities, Arvada, Colorado in "Summer of Watercolor" June 1 – August 26, 2007. Each WFWS Show is planned by a committee of two artists from each member society. The host society underwrites the upfront expenses of the show and also recruits literally dozens of volunteers to stage the show and assist Museum personnel.

John's abstract mixed medium painting "Battery Park II" was awarded First Place in the **Experimental Category of Artist** Magazine's competition 2000, judged by Edward Betts. John is represented by Bryant Galleries, Jackson, Mississippi and Bryant Galleries, New Orleans, Louisiana. ■
