## ere you aware that the WFWS Committee is answerable to the CWS Board?

ecisions regarding the WFWS show, juror, finances and location are subject to approval by CWS Board before the committee can move forward. The name of the show is "Summer of Watercolor"; the time has been set in 2007 starting with the delivery of the paintings in May and ending with the removal of the paintings in August; the juror, John Salminen was chosen; and the location of the show is the Arvada Center. with the WFWS Show on display in the lower level and the CWS State Show on display in the upper level. The Committee anticipates up to 150 paintings from WFWS members with approximately 125 paintings from Colorado artists, including CWS members, for the CWS State Show. Start your paintings now...CWS members will have a big impact at this show!

### Things to consider when entering shows!

Reasons artwork can be rejected from shows excerpted from a variety of jurors of recent shows

- Lack of creativity
- Lack of skill with materials not what but how it was painted
- Lack of harmony
- No center of interest
- Poor composition unrelated subject matter
- Bad design uninteresting

- shapes and arrangement
- Technical accuracy of subject matter
- Originality copying art or prints
- Lack of imaginative approach – don't take the easy way out
- Parts of the painting were

- good but other parts not comparable
- Contrived or awkward pose to avoid skill and detail
- Good work but better work of same theme in the same show, artwork didn't fit the showing space/size
- Presentation of the artwork

- poor matting or framing.
