President's Message

President's Message for November 2006

What motivates you to paint? Have you never been asked why do you paint? Do you have an answer to this question? You would be surprised at how often artists are asked this question and to their amazement many artists don't have an answer. Sometimes they fumble around in their minds trying to answer the question with some profound statement, but the answer maybe very simple.

When you think about what motivates you to paint maybe it is for one of the following reasons. Do you have the need for just plain artistic expression? Do you just have to paint? You don't know really why but it is inside of you and you have to do it, all the time, no matter what. Or do you paint for the personal reinforcement that you receive as an artist from the public recognition. Do you enjoy the recognition from being noticed as an artist? Does it plump you up to hear how good you paintins are?

Maybe you paint for the pay. Do you enjoy selling your paintings and reaping the cash rewards of a sale? Are you driven by the need to produce more paintings so you can sell more? Do you look for the shows with the highest prize money? Or do you paint for the rewards of the awards that an artist can obtain such as winning a ribbon in a show? Are you always trying to win the "Best of Show"? Or does your motivation to paint come from an intrinsic value of paint. What does that mean? You

just paint because it is a natural thing for you to do and you enjoy it.

What ever your reason for being motivated to paint, be involved in it to the fullest. You have to walk the walk. If you say you are a painter, you have to be involved with your painting. How long has it been since you finished a painting? Do you paint once a week, once a month? You can't say, "I'm a painter" and only paint every so often. Painting has to be a habit or a routine. You have to make painting a part of your everyday life.

You need to surround yourself with what it is you want to be. Find a mentor, someone you like their paintings and take a class from them, work with them in their studio. Look at books or prints or posters of the artists you like and fill your studio with them. You have to have the resources at hand to look at and review.

Whatever the reason is that you paint you are in control of the results. If you are not happy with why or how you are painting make a change in the habit or the routine. Look to raising the level of your painting by changing something in how you paint. Maybe it is as simple as refocusing your reason for painting.

Digital Image Submissions by Gene Youngmann, CWS, Exhibition Manager for WFWS32

Have you looked at the prospectus for the WFWS32? Have you considered how you will enter this year's WFWS, slide or digital image? If you are considering digital image for you entry, now is the time to begin preparing your entry as it does take time to do this process. As slide entries are becoming harder to produce because of the fewer suppliers of slide film and reduced number of companies that will still process slides, you may want to take the plunge and use a digital image for WFWS32.

In the WFWS32 prospectus was a colored insert that explained the digital image submission process. It explains how to send your image electronically and how it should be labeled, where to send your image and by the due date of midnight Friday, January 12, 2007. You also have to send your entry fee and form to your delegate so your entry is recorded under your society.

What is missing is where do you go to get a digital image produced. There are several ways to do this. If you have a good quality digital camera and you have experience taking pictures of your artwork with it you can produce your own digital image. You may have a son or daughter who could do this, or even a friend. Whatever the case the end digital image must be in a "jpg" format.

You could also consider going to a digital image service like at a camera

store or independent service. Remember they are going to charge you for the time they work on your image and will give you your image on a CD disc. Be sure that if you use a service that they too produce your image in a "jpg" format. Some services will even send your image for you if you do not have access to the Internet. The colored insert in the prospectus includes the email address if you consider doing this. Be cautious about the amount you pay for the production of a digital image. Some services will charge \$20 to \$40 for one image. This may seem high but the quality is much better than any slide. Ask about the charge before you have a service produce your image. Shop around, you should not pay more than \$20 to \$40 for one image. Remember it does take sometime to have this done, usually one to two days. So plan ahead.

The quality of a digital image is superior to that of a slide. Digital images have more clarity and truer color in relationship to the original painting. It is important that the digital image look, as close to the original painting as possible but that does not mean that you should or need to enhance the image in the computer. In fact there should be no enhancement of the digital image at all. What the digital camera or digital scanner sees is want we should see when we view the digital image submitted.

Take the plunge and have your entry this year digitally produced. I believe that you will be amazed by the quality and the results. Who knows maybe your chances will be increased with a high quality digital image. Good luck and try a digital image.

Tuesday night, November 21st, our own **Jean Cole**, CWS signature member, has generously agreed to be our Critique Artist.


Jean graduated from the University of California at Berkeley with a degree in design and pursued a career in interior design before returning to her great love. watercolor, in the early 1980's. Her glazing technique and the brilliant use of color in florals and still lifes have led to numerous awards including Best of Show at the Rocky Mountain National and the Paul Schwartz Memorial Award from the AWS. She is also a member of the National Watercolor Society, the Rocky Mountain National Watermedia Society and the Colorado Watercolor Society. Her work has been published in "Best of Watercolor 2", "Basic Flower Painting", "Watercolor Magic" and "The Artist's Magazine". Jean's work has been in galleries around the country and is in prominent national and international collections including the Leanin' Tree Museum of Western Art, Storage Tech and the Sisters of Charity Healthcare System.

"Through my paintings, I want to open the viewer's eyes to the beauty that surrounds us in ordinary objects and small intimate places. Beautiful flowers, the bounty of produce, the sparkle of glass or even the cast offs at the back door catch my eye. I often choose to do close-ups in a larger than life scale to bring into focus the everyday things in life and cause the viewer to pause and reflect on their exceptional qualities."

"As I paint, my emphasis is on the patterns created by light and shadow, color and line and the translucent quality of the watercolor medium. These comprise the abstract pieces that make up the representational whole of the painting. I use a rather controlled and detailed approach, working from my own photography. I employ the technique of layered washes and glazes because it enables me to achieve a depth and brilliance of color, which stimulates the eye, and best captures the intensity and luminosity of color."

"I hope to inspire us all to recognize beauty in what seems to be ordinary and consider that it is a unique gift."

Carla was always drawing as a child. However, other than a few private lessons with watercolorist Carol Mack during high school she is a self-taught artist. While attending high school in Cody, Wyoming, she was surrounded by beautiful scenery and a very active artistic community. Artists such as George Dee Smith and James Bama attended many functions in Cody and furthered her interest in art. With considerable support from her mom, she produced a number of pen and ink paintings then, following completion of a B.S. in Natural Science and

Mathematics, pursued a career in the business

world. After getting married and having her first child, she was again encouraged to paint. On a whim, she painted a picture for her mom, took it in for framing and was commissioned to paint a picture for the framer's wife. With two small children and all their activities, Carla only had time to complete a few commissions each year. Once the kids were in school, she was drawn into the business of education to fulfill her kids' learning needs. With her children now in high school and

college, Carla is again ready to focus on painting, broadening her subject matter and explor-

ing new media now available.

As a signature member of the Colorado Watercolor Society (CWS), Carla has participated in the member shows including the CWS Botanic Garden Shows and State Watermedia Exhibitions. She has also exhibited at the Castle Rock Artfest, the Littleton History Museum's Arts and Crafts Show, the Parade of Homes, a number of local galleries, and Denver Orchid Society shows where she has won "best art collectible" of the show. Her art can be found in private collections locally and around the country as she enjoys working closely with clients to bring their ideas to life in commissioned artwork.

Carla specializes in transparent watercolor paintings of flowers (both botanical and contemporary), birds, mountains and fish. She was inspired by the work of John Stuart Engle's reflections and photo-realism, Robert Bateman's ability to capture the essence of the animals he paints, and Thomas Moran and Albert Bierstadt's fantastic landscapes. With these incredible artists as motivation, Carla strives to create realistic, representational art and continues to search for new ways to improve her painting abilities through books, workshops and demonstrations.
