Conceptual Abstractionist Mark Brasuell to present himself and his art at April 21st meeting!

Mark Brasuell taught his first art class when he was 15 years old. His background includes sculpture, jewelry-making, self-portraiture, mixed-media and performance art. Currently, he paints, using acrylic and oil pastel on canvas or Mylar. One of Colorado's most important abstractionists, he was included in the recent two-part Colorado Abstract show and in the accompanying book, Colorado Abstract: Paintings and Sculpture.

Mark Brasuell's work revolves around personal experience, using energy, emotion and physicality to create what he calls conceptual abstraction. He begins a piece with a vague idea of the emotional impact he wants the work to have but rarely knows what it will look like. He proceeds, guiding the painting from his mind to the canvas, reserving all judgment until the final 10 to 15 minutes of the piece. The results are beautiful, lyrical paintings filled with vibrant color and the emotional impact that comes from his view of himself and the world in which he lives.

Mark is a founder (and now president) of EDGE Gallery in Denver. He teaches life drawing at Metro State College, holds a B.F.A. from Texas Tech University and a M.F.A. from University of Denver, where he has also taught life drawing.

The evening of the 21st will provide a look at the mind, life and work of a very exciting and personable artist. It is definitely a "don't miss" meeting. Mark is bringing his whole drawing



class with him—you are also welcome to bring a guest. Come prepared for a memorable evening and go home inspired to enter the New Trends Show with something very new and very exciting!

Message from the President

A PRIMER ON GALLERY ETTIQUETE

Spring is here, and with the renewed optimism of sunshine and warm weather, we all are crossing our fingers that the economy is bouncing back. Let's hope the public is back in a buying mode and considering the purchase of original artwork. And along with this season of renewal, the creative gods have smiled upon you...a gallery has invited you to join its stable of artists! You've been waiting for this opportunity, searching for it. Getting that acknowledgement from a gallery is akin to gaining bonafide recognition and credibility as an artist. It's sort of an unofficial seal that your work is good enough to warrant exhibition in a real gallery – something well beyond showing off for close friends and family. Truly this is a big event for any aspiring artist.

But did you know that there are some unwritten rules to exhibiting in a gallery? Nobody tells the artist about these rules. Many of us stumble along and make unforgivable mistakes in blissful ignorance, not realizing we've blundered or made a faux paux, perhaps offending the gallery owner in the process. Or worse yet, did our unwitting misstep possibly jeopardize our privileged status? Let's make sure we don't stub our toe unnecessarily!

Always remember that the gallery owner is taking the risk. They own their business, and must pay the mortgage or rent on their gallery whether anyone buys or not. So every decision or comment you make must be made with that in mind. The gallery is promoting you and your work. Be responsive to their requests for your presence and input. You may be asked for a resume, an artist's statement, and other background information. Make it interesting, the gallery is hoping to capture the imagination of its customers. Every painting ought to have some interesting story to tell — something the gallery owner can share with a potential buyer that's interested.

Not all of us are good with a sales pitch. If you are uncomfortable talking about your work with a customer, let the gallery owner know, so they do not put you in the awkward position of having to talk about yourself, your painting, or what inspired you to produce a particular work. Just be sure you are able to give the gallery owner something to work with so the owner can tell a potential buyer about your painting's backstory. After all, the inspiration behind a painting is often what inspires the customer to purchase!

Each painting is "one of a kind." Don't devalue your work by telling a potential customer you have many more just like this one back in your studio. A customer needs to view a painting as unique, and once gone, never to be re-attained. Make it special, rare, unique! (Yes, you may be able to crank out five more tomorrow, but the customer does not need to have that information.)

Keep some consistency to your pricing. Some artists price by the square foot or by the square inch – seemingly a silly practice when any artist knows that one small painting may have far greater value than a labored, overworked larger painting. But customers generally don't understand this. Make sure your pricing follows some common thread so there are no wildly differing values of your work on one wall. You

don't want customers second-guessing what's behind some irrational roller coaster pricing between paintings.

When a gallery hosts a special event, it is expected that the artist(s) share in the hospitality. Bring some food, some drink, or something that shows you care and are making an effort to entertain the gallery's customers. The gallery owner has undoubtedly worked night and day getting the place to shine, adjusting lighting, rearranging walls, and most likely cooking up some hors d'oeuvres. If the gallery owner sees you are just as committed to making the event a success, your work will get promoted just that much more. And do try to mingle during the event, socializing and talking to potential customers. You, too, need to be a gracious host – people are coming to see your work!

And while the gallery owner may ask you to share your mailing lists. be assured the gallery is paying for advertising and working every public relations contact. So do NOT bring your business cards to hand out to the gallery's customers. These are NOT your customers. Protect your gallery by always referring interested customers back to the gallery. Do NOT have them call you direct after a show. If a customer wants to see additional work, arrange for the work to be delivered to the gallery and have the customer meet the gallery owner there to go through new pieces. This reinforces your relationship with the gallery and it strengthens your position as an artist by having them deal with your gallery agent. By working around your gallery owner (for any reason), you seriously undermine your relationship with the gallery. And never quote a wholesale price or a reduced price to a customer – maintain the same pricing that is found at the gallery. It solidifies your credibility. Once a gallery owner suspects or hears you have undercut the gallery, you will guickly find yourself without gallery representation.

Most of this is common sense, but it always amazes me to hear how easily we can unwittingly stumble and make silly mistakes jeopardizing this valuable relationship. Protect and nurture it and your reputation as a serious artist will grow. Good luck, and keep painting!

MEMBER PROFILE by Molly Squibb

Valli McDougle isn't just a successful artist – she's a whirlwind.

Valli joyfully experiments with a dizzying variety of styles and mediums, from poured watercolor to mixed media collage to Hydrus watercolor on rice paper. It's no wonder she's so prolific - Valli nurtured a lifelong dream to try watercolor painting, and now she's not going to waste one glorious minute!

This art latecomer had never picked up a brush until the year 2000, thanks to a demanding, 30-year career in politics and public affairs. She spent 10 years on the staff of U.S. Senator Charles Percy of Illinois, wrote editorials for a CBS-owned radio station and was an academic administrator at the University of California San Francisco, all the while keeping her art aspirations alive. Finally retired and living in La Jolla, Valli tirelessly sought out art teachers and fellow artists, immersing herself in what she calls "my passion for colors, textures and designs."

She launched her art career during a year-long Landmark Education Wisdom course on creativity and spirituality, especially useful to her because she had to commit to pre-set, written goals. Working first in decoupage on glass and then watercolor, "I went into it thinking I'd do it as long as I had fun. Painting gave me the sense of being able to play," she says. Teachers like Joan McKasson urged her to paint loosely and experimentally from the get-go. To this day, she calls large, abstract compositions in vivid colors, "my greatest pleasure."

Valli's award-winning work has been featured in many state and regional watermedia shows, and can be seen at Artful Things on Tennyson, Art & Framing at Stapleton and other local venues. She also puts her administrative skills to work volunteering for art organizations: as a former president of the San Diego Watercolor Society and now for CWS, where she's co-chair, with Lionel Sanchez, of this spring's statewide watermedia exhibit.

Key to Valli's art is what she calls the "happy accidents" of painting. She points to an in-progress abstract from her "Windows on the World" painting series. "This area suddenly looked like the Golden Gate Bridge to me, so maybe I'll do something with fog effects." In other artworks, left-over paint is poured onto paper for surprising, spontaneous results. A cup mark left on a sheet becomes an otherworldly moon shape.

The final outcome of each "Windows on the World" artwork is usually unforeseen. "What I love about creating these paintings is working with acrylics much the way one does with watercolors, and discovering the surprising effects one gets with layers of color. I feel very energetic when painting this way."

It's the mystery of an unfinished painting that draws this non-stoppable artist to her studio every day. When asked "What do you see yourself painting five years from now?" Valli McDougle just laughs and admits, "I have no idea!"

- President Randy Hale called the Board meeting to order at 4:32 PM.
- Board Members Present: Randy Hale, Gene Youngmann, Sydney Eitel, Pat Dall, David Castle, Pat Foster, Elaine Campbell and Holly Beazley.
- The Board approved the February, 2009 minutes as corrected.
- Sydney Eitel reported that the Nominating Committee had decided on a slate of new Board officers for the coming year, but that no candidate for President-Elect had been found yet.
- Randy Hale reviewed web design proposals with the Board; an ad hoc committee of non-board members has been formed to do more extensive evaluation of these proposals so recommendations can be made to the board before moving forward.
- Randy discussed next steps for a revamped CWS website and provided a brief overview of several web design proposals to update the current website. The Board discussed that a small ad hoc committee be formed to review them and make recommendations to the Board.
- The Board discussed the possibility of using CaFE, a web-based service, for digital entries by the 2010 State Show.
- Elaine Campbell reported that the three-day Mark Mehaffey workshop is full but members may still place their names on a waiting list. The five-day Ted Nuttall workshop scheduled for October 19-23, 2009 is also full and wait-listed.
- Pat Foster announced that the plans for the State Show have been finalized. Over \$6,200 in awards has been pledged to date. Pat has also signed contracts for the New Trends Show with Co-Art and for the Members Show with Old Firehouse Gallery.
- The meeting was adjourned at 6:20 P.M.

Images must be jpeg format, 1200 pixels in the longest dimension, and 300 dpi. To name your file, use the first four (4) letters of your last name, a hyphen, the first four letters of your first name, a hyphen, and your painting title (i.e., cast-davi-tulip stand.jpg). Be sure to use the .jpg extension. Write your name, address, phone, e-mail address, and image title(s) on the CD. Along with the CD, enclose a printout of each digital image (maximum size 8.5" X 11"). The printout is for office reference only. BE SURE TO MAIL IN THE ENTRY FORM ALONG WITH YOUR CD.

Entry Fees (non-refundable)

Entry fee for one slide: \$20 total Entry fee for two slides: \$25 total Entry fee for three slides: \$30 total

Entry Requirements

- Entries must be predominantly watermedia. Collage and other materials may be incorporated. Grounds can be on yupo, canvas, illustration and scratchboard, glass or any paper.
- Work must be completed in the last two years and not previously shown in a juried CWS or WFWS show.

Presentation

Artwork must meet gallery quality standards. It must be ready to hang. The wire should be 1/3 down the frame and slightly taut. No saw tooth hangers. White and off-white mats are preferred. No cracked or chipped glass. Artist's choice of glass or plexiglass if traditionally framed.

Liability

Utmost care will be taken in handling paintings; however, neither CWS nor Co-Art Gallery will be responsible for any damage to any art submitted to the exhibit. All insurance is the artist's responsibility.

Commission

A commission of 30% will be taken on all sales. PAINTINGS MUST BE FOR SALE.

Additional Information

- Accepted entries must be properly framed and ready to hang, with an ID label securely attached to the back. CWS reserves the right to refuse any work not satisfactorily framed or not meeting its standards.
- Information recorded on the entry form is considered final and may not be changed.
- Any requirements of the exhibit not fulfilled will result in disqualification.
- Works juried into this show and not delivered for exhibit will prohibit the artist's entry into this exhibit for two years.
- No exhibited work will be released until the close of the exhibit.
- Bin work will be accepted: all artists entering this exhibit may bring three bin pieces.
- No sitters, reception or hanging committees will be required.
