FEBRUARY GENERAL MEETING IS A VISIT TO REDLINE GALLERY ON FEBRUARY 13

This year our annual site visit to a major Denver gallery will be to the RedLine, located at 2350 Arapahoe Street near downtown. This is a relatively new gallery and, as the material below illustrates, its mission, its purpose and facilities offer programs and opportunities unique in the Denver area. Its exhibits are a bit edgier, there are nine in-house studios, and its education outreach is very innovative and fundamental to its very existence. A new show, being installed during our visit, is titled Love Lines, Analyzing Love. The title alone suggests that it might be interesting.

Our plans are to meet in the main entry space at 1:00 p.m. on Saturday, February 13, 2010. We will be met by lan Fisher to receive a brief overview of the facility and its programs. He will also be happy to answer our questions. We will then be free to wander about, see the new show and visit with the in-house artists. Since the gallery is open to the public there is no way to gage just how busy they may be. Parking is available on site for about 20 cars but, being a Saturday, street parking should be plentiful.

In the event of a snowstorm, our snow day is Saturday, February 20. In setting up this program, I've visited the facility twice. Please join us. It is a very interesting and innovative gallery, and the new show sounds very intriguing. Note that this replaces our General Meeting normally scheduled for Tuesday, February 16!



Red Line Gallery

RedLine's mission can be understood as three dynamic, fluid, concentric circles - art, education and community service - that overlap, flowing into each other and outwards into the surrounding space.

First, RedLine provides emerging and midcareer visual artists with an immersive environment for studio practice, reflection, collegial dialogue and communal service.

The second "circle" at the core of our mission is the mandate to connect RedLine's artists and its resources to the larger community in which we are embedded. We believe in the transformative power of art and we are committed to bringing that vision - as well as practical strategies for its realization - to the "neighborhood."

Third, RedLine is especially committed to cultivating educational outreach programs and events that will be responsive to homeless or "displaced" populations, to teenagers, and to local school curricula. RedLine will be a "safe place" for the community to express its creativity, collaborate with artists on projects that directly impact their lives, and to be exposed to processes and strategies for inventive problem solving and creative teamwork.

THANK YOU COLORADO WATERCOLOR SOCIETY ARTISTS!

Fifty Eight of us submitted 123 paintings for selection from juror Carla O'Connor to be in the WFWS35 Exhibition in Utah. CWS was well represented. I know that it is tough news when your work has not been selected. I am one of the 38 artists who did not have a painting accepted. I want to offer a few words of encouragement before I congratulate those who did.

There were so many beautiful paintings that did not get accepted. When you consider that there were a total of 1082 entries, the competition was strong. And then it comes down to one juror narrowing this down to 100 paintings. One reason some of our paintings were not chosen, was that they were eliminated because they were too old. Rules require that paintings be painted within the last 2 years. Did you know that digital entries tell the date the photo was taken when it is downloaded? I will notify any of you who had this happen so that you will know what has happened.

If this was not you, your guess is as good as mine as to why your painting was not selected. You will receive a catalogue with color photos of the accepted paintings. I have heard that many times the paintings that are chosen for awards won't necessarily make you comfortable. The general public won't necessarily purchase them because they make them uncomfortable. The good news with this is that the paintings not selected, many times are very marketable to the general public making them saleable. AND we can all try again next year! Let's set a goal to make it into WFWS36 hosted by New Mexico Watercolor Society.

Member Profile: Barbara

Moore

Barbara Moore is passionate about painting and considers herself fortunate to make a living doing something she loves. Her father, a talented cartoonist, turned down a job with Disney because he loved to fly. Raised as an "Air Force brat", Barbara remembers the cartoons her father often drew for his children.

Barbara studied fine arts at Bellevue University in Nebraska. Although her degree was in oils, she had exposure to all media. So what prompted her switch to watercolors? None other than the family dog. One day as she was painting, the dog spotted a squirrel in the yard and leaped right through

her easel, creating a huge oily mess! That was it for the oils. Soon after, she and her husband moved to California, where Barbara studied under leaders of the California watercolor school at its height. She enjoyed painting landscapes and street scenes.

Having painted the towns wherever she lived, Barbara was stunned to discover that nobody was painting scenes of Old Town Fort Collins when she arrived there 20 years ago. She quickly filled the void with her watercolors

and prints. The founder of Discover Fort Collins magazine asked Barbara to paint his first cover page. A decade later, she is still the cover artist. Recent paintings of her grandchildren building a snowman and feeding ducks in the park are among the most popular covers.

Barbara spends half her year producing paintings and the other half selling them. From January to May, she paints daily in her studio. June through September, she participates in Colorado art shows.

In winter, she puts in a full day in her studio. After a morning workout she is painting by 8:00 am and doesn't stop until dinner time. Barbara works on one painting at a time starting with a detailed drawing. She concentrates on getting composition and values right, which contribute far more to a painting's success than laboring over fine details. She likes to paint "big" using full sheets, and uses masking frisket "by the bucket" as she builds up washes to balance values. By the end of each day, she is exhausted.

Barbara rarely paints in the field, but spends time observing nature. She may sit for several hours among the autumn elk in Rocky Mountain Park, snapping the occasional photograph, making a guick sketch, or just taking in the scene.


During the summer she has no time to paint as she bounds from one art festival to another. She had early success with art fairs. At her first show, she sold all but one of the paintings at her booth. She offers something in all price ranges from

\$2.50 cards to \$4000 framed originals with a variety of prints in between. Barbara advises artists against painting what they think will sell. "Paint what you are passionate about and then figure out where to market it. If you love dogs, sell at dog shows."

A two week trip to Italy has inspired her most recent paintings. In her Italian scenes, Barbara focuses on capturing the light. She loves the luminosity one can achieve with transparent watercolor. When she finishes her Italy series, Barbara plans to channel her fascination with light into paintings of the Colorado skies.
