Since 2020 was a period of transition for us, the whole country, and the world, various things are changing. We, your Board, are working on figuring out the best shows to have in 2022 and the future. One thing I want to address that a lot of you are still unclear on is use of photos for your work. You may only use photos that you, yourself have taken for a painting that you enter in a CWS Show. If you are NOT entering it, you may do what you want, but any major exhibition will have the same requirements. Original, no copy! You may not use anyone else's photo even if they give you permission. You may not use anything from magazines, internet, TV, or print for show entries. So the question becomes, what if you want to paint something you don't have a photo of. Well, you should only paint what you know. Your paintings will be better if you know and understand your subject. Or maybe you have a good imagination, then you can make up what you think something looks like in your head. That can be pretty interesting! Think Picasso or Modigliani.

But say you have a few photos of a certain bird that you want to paint. You only have a few, but one is a great composition for a painting. However, in your photo, you can't quite see what the color of the spots on the wing are. In this case, it is ok to look at a bird book to find that bird and see what the colors are. This is what using a reference photo means. We will not put that in the prospectus, because too many people think a reference photo means you can paint someone else's photo. It doesn't. So I won't put that in the prospectus. But for your knowledge, that is what using a reference photo means. It is only reference for a certain aspect for which you need clarification, NOT copying.

Lorraine Watry of CWS and a signature member of NWS paints beautiful birds in fantastic compositions where she has won numerous national awards. She takes hundreds of photos of birds, or anything she wants to paint, and that's how she gets her incredible paintings. So if you want to paint award winning work, follow that example. I love my cell phone because I am never without a camera!

SEPTEMBER 21, 2021 BOARD IN BRIEF

- 1.0 Board and Committee Reports
- 1.1 Bea explained that there is an interest in not continuing the New Trends/ Directions show as such but making the Member's Show rules flexible for media and framing. Another concept is to add a themed show. The intention is to maintain quality of our shows but to have at least one show per year where any member can show their work. Four venues are already lined up for next year, so we can have two themed shows. Jeremy moved and Elaine seconded allowing varnishing of paintings in all shows. This was approved unanimously.
- 1.2 Kathy agreed with making the coming Aurora show "Do it Your Way". It would be open to all watermedia, finishes and framing. We will continue to think about nationalizing one show per year.
- 1.3 VP of Programs Carol Newsom discussed upcoming programs including Stephen Quiller, Sally Nisson, Lorraine Watry on zoom and perhaps a critique in February.
- 1.4 Priscilla distributed financial folders to members including a re-cap of previous financial statistics. Priscilla worked with the bookkeeper to clear out old unused funds. As always, part of our total funds are being held for hosting a future WFWS show.
- 1.5 The Post Office box has been closed out.
- 1.6 There were 61 entries in the Explorations show and only about 44 were accepted. Suzanne says we sold five pieces
- 1.7 Sandy said the Quiller Workshop is full (25) plus a waiting list.
- 1.8 Martha Lancaster and Theresa Shepherd were approved as new Signature Members and we anticipate 3 more by the next meeting. CWS currently has 366 total members.
- 1.9 Jay says we're almost done with policy revisions for the Bylaws. Submitted by Jeremy Jones, Board Secretary



OCTOBER 19, 2021 BOARD IN BRIEF

- 1.0 Board and Committee Reports
- 1.1 Carol said that Bea has requested that we hold 3 shows a year and the Members Show (without a Jury) is very important. Kathy assumed this would mean a Members Show, State Show and a themed show. Beatrice and others have suggested that the Members Show would be the "Do It Your Way" show to allow the most options and benefits for our members. Since many venues are already signed up for 2022, 2023 would be the first year to just have three shows. Everyone agreed that sticking with Lakewood for the Members Show in 2022 was a good idea and hoped this would be a regular annual event.
- 1.2 Carol stressed the importance of raising CWS dues to \$40 per year and to raise entry fees for shows to \$30. We will vote next month.
- 1.3 Carol suggested that payment for all CWS shows should be by website from now on. Jeremy moved for all shows to be paid for by website from now on, Carol seconded and the motion passed unanimously.
- 1.4 Kathy reported that Chris Stevens has committed to CWS having the 2024 State Show show at the Curtis Gallery. They handle most of the set up and provide the reception so it is easy and it costs CWS less to have exhibitions there.
- 1.5 Bobbie Ruh, new Treasurer, commented that the bookkeeping by Joan had been very good and that helps her in getting organized. She noted that bank statements will now come at the end of the month. She plans to put the WFWS funds into a separate account to avoid confusion.
- 1.6 The CWS President must approve checks or expenditures on anything over \$350 or not already in the budget. Income and expenses should be published for each show.
- 1.7 Kathy commented on a spreadsheet showing individual transactions and total income can be uploaded by show on Art Call. However, deposits to our bank account are made by the payment processor, Stripe, and they don't identify which show transactions apply to.
- 1.8 The Treasurer said profit and Loss statements will be published Monthly in Quickbooks format. Jay moved for approval of the budget that had been submitted in September, subject to revisiting it if necessary, because the incoming Treasurer was in the process of getting up to speed. The Motion passed unanimously.
- 1.9 Jay stated that the recent Policy changes should be posted for consistency with Bylaw changes that led to them.
- 1.10 Sandy stated that CWS will make about \$ 5,600 on the Quiller workshop. Sandy is working with Birgit O'connor on a workshop in early 2022. Randy Hale is scheduled for April, Keiko Tanabe for July and Rene Eisenbart for next September.
- 1.11 Elaine announced that Nancy Dee, Melanie Mont-Eton, Terry Laugham, Theresa Shepherd and Martha Lancaster had qualified for Signature membership. Carol moved approval and Jay seconded. The memberships were approved unanimously. Elaine says we now have 343 members and that raising dues is a good idea. Everyone agreed again to raise the dues to \$40 next year.
