As you know, it is not a juried entry and you may enter any one painting you wish. More will be coming your way about entries.

I wish to address you all about show entries. Our entries have been down for all our shows and that's not a good thing. We depend on entry fees to actually cover the cost of the shows. If we don't get enough entries, it's possible that we would have to cancel the show. One of the things the Board has done to help is to try and find venues that don't charge us for their space. That's not always possible, but when it is, it helps. However, we still have to hire a juror and put on a reception, We also have expenses to just run CWS, such as the church rent, insurance, storage locker rent, bookkeeper in addition to our Treasurer, a professional tax preparer, paper, printing, postage, and awards, just to name some of the basics. We look to our membership dues for a lot of that, but we also need shows to support themselves.

If we don't have enough entries, our other problem is that there is no competition, so it might as well not be juried. Every show would just be a Member's Show and everyone just brings whatever they want. Competition is good because it forces us to work harder, learn more, study what we are still lacking, and try to improve. That's good for our brains no matter the age. It is also the basis of what the Society was formed for, to learn, improve, and then gain signature status.

So I am just asking that we all try to pay attention to show entry dates and enter. We want to keep CWS healthy and active and of high caliber. You all are talented and we have all levels from beginners to extremely advanced. For those of you who are newer to watercolor, remember that those who are advanced were once beginners as well, and they have advanced and benefited from the competition of being a part of what CWS has to offer.

I hope you had a wonderful summer, stay safe and healthy. Come to the reception of the Theme Show in Central City when it opens in September. Then we, the Board, look forward to seeing you September 20 at Plymouth Church for the beginning of our new year! See old friends, meet new friends! We have a great lineup of things to see and learn. 

## **CWS Board in Brief**

### Colorado Watercolor Society May 17, 2022 Board Meeting

- 3.0 Board and committee reports
  - **3.1 President**: Beatrice: The Western Federation of Watercolor Societies meeting in Albuquerque was a great success and 12 Colorado artists had their work in the high-quality show. Randy Hale and Linda Renaud both won substantial prizes.

**3**.1b There was further discussion of problems facing art groups and other groups as well. People tend to stay home or do activities with neighbors rather than with larger groups. Jay noted that getting together was still a big draw. He said when the last meeting didn't take place, people still stayed to talk with their friends. Bea mentioned the amount of effort it takes to put on a Zoom meeting and how it just doesn't replace the group interaction of a live event.

**3**.1c Bea says Kathy has mentioned that the current arrangement of having a different person in charge of each show is not working because she has to train each person (and sometimes the juror) to use Art Call and to learn the typical procedures. She suggested one show person per year.

3.2 Vice President and Program Director: Carol said that the equipment in the front of the Church meeting room has been removed and will not be brought back. That allows use of the large screen and more flexibility.

3.3 **Treasurer**: - Bobbie Ruh: The Board was familiar with the Treasurer's report prepared by Bobbie Ruh and expressed no questions or concerns about it.

3.4 **Secretary**: Georgia started training at this meeting shadowing Jeremy and taking her own notes for practice. Jeremy is sending her formats and e-blast information.

3.5 **Exhibition Director** Kathy was absent so Jeremy (who is handling the Theme Show: Colorado People, Places and Things) reported that the first draft of the Art Call website has been completed. Images are due July 19<sup>th</sup>. Images will be selected and participants notified August 1. Paintings will be delivered to the Gilpin Arts Association Gallery on August 27 and will be judged on September 2 prior to the 5 p.m. reception and 6 p.m. awards presentation. The show will be hung by Michele Rousell, gallery director. Paintings will come down on October 26. 3.5b Gene Youngman, noted that there is still a provision to contribute \$25 toward a scholarship in memory of each member who passes away. This practice has not been followed. *Jeremy moved and Suzanne seconded that this practice be officially terminated.* 

### Approved unanimously

3.6 **Parliamentarian Director**: - Jay reported that **voting** in favor of the recommended slate of Board Candidates was 105 to 1 and it was 98 to 5 in favor of the dues increase. (Later voting in the Member's Meeting brought the total for the slate to 108/1 so Board Members were deemed elected and were sworn in at that point). Also, the annual dues are now \$45/year.

3.6b Jay read the procedures portion of our bylaws to clarify issues about the \$25 contribution to scholarships upon death of a member. Next, discussion continued on the definition of what is a society and when that impacts acceptance of a painting in CWS shows. Apparently WFWS is working on this issue and we will probably follow their lead.

3.7 **Workshop Director**: - Sandy said Randy Hale's workshop was a big success and he did a very good job. They made about \$2,700.

3.7b 23 of 24 seats have been sold in the Keiko Tanabe workshop that will be held at Red Rocks Community College July 14-16.

3.7c There was discussion of an additional person interested in the marbeling workshop who wanted a list of the registered attendees. They seemed interested in also doing a marbeling workshop but the board advised avoiding competing workshops even though the original workshop is limited to 13 people. Further discussion may generate additional activities related to the proposed CWS play day including the use of the second person's studio.

3.8 **Website Director**: Shanthi reported that there had been two fake \$1,500 donations on the website by a person pretending to be a member and she has deleted them!

3.9 **Membership Director**: Elaine suggested that CWS could use a PR person. There may be people who are interested in CWS activities and just don't know about the organization. Amber pointed out that these days the most effective way to do that is through social media. This helps target younger artists but it does take a lot of time.

3.9b Dues at the new rate of \$45/year are due by June 1.

3.10 **Director At Large**: Suzanne will be writing thank you notes to all who contributed to the Chuck Danford Memorial.

3.11 **Director of Collage**: Amber reported that the June-August edition of Collage will be released soon. She and Jeremy are talking about how to transition management of that activity. One issue is that Newsletters are typically done using InDesign, which combines Publisher and Illustrator and has fewer glitches than Word or other word processors. However, it is sold as a subscription for \$20/month even if you only use it once a month.

4.1 **New Business**: Gene Youngman, former CWS President, stated that 68 artists entered a total of 153 paintings for the State Show and 58 paintings were selected. Paintings will be dropped off June 3 at Red Rocks Community College in Lakewood and the show will run until the CWS Theme show opens!

4.1b Gene said CWS needs to standardize the names for awards at the State Show and most of the awards would have the same names as awards in other CWS shows. *He suggested the following:* 

Best of Show \$750 Founders Award \$400 (State Show only) Chuck Danford Memorial Award \$300 (State Show only) 2 Awards of Excellence \$250 2 Merit Awards \$200 (or honorable mention) 4 Honorable Mentions \$100 The amounts of awards can be changed by the board depending on income for the show. This item will be further discussed in future meetings.

41.c Gene also mentioned that Chuck is still painting and that *it's time to get the Arvada Center signed up for the CWS version of the WFWS conference.*

3.5d: There was a lot of support for having a publicity person or committee.
