### A Hepfull Hint

Although I am not a big fan of using masking fluid, there are times when it is very helpful in getting the results you want. In my painting, "Home Sweet Home", I wanted to reserve the white of the cobweb while I was working on the background of the painting. To get the results I wanted I used a drafting ruling pen. I applied the fine lines of the cobweb by dipping a ruling pen into masking fluid. You can get a variety of lines by adjusting the width of the tip of the ruling pen. The ruling pen also holds quite a bit of masking fluid in the tip of the pen. Give it a try next time you want to reserve white lines in your painting.

Carol is a native of Fort Worth, Texas, with a love of art which took shape after

graduating from the Art Center College of Design in Pasadena,

California, where she met and married a fellow art student, Tom Newsom, who is also an amazing artist in his own right – another story for another time.

Being an artist in corporate America didn't appeal to Carol as much as being a free-lance artist. Armed with a portfolio full of her artwork she set off to acquire an agent in hopes becoming a commissioned illustrator/artist. It worked to an amazing degree as she currently has over 200 children's books to her credit — an awesome accomplishment for this soft-spoken artist.

Of note with all the books Carol has illustrated, almost all of them are done with watercolor. She loves the brilliance of color that watercolor provides for her youthful audience of book readers. And, watercolor's inherent features of layering and lifting give her the flexibility she requires to tell a visual stories.







While her children's book illustrations have kept her busy for over 30 years, she still wanted to be a fine artist. She also paints with watercolors for various art galleries and to show her art through juried exhibitions. To Carol's way of thinking, the transition between commissioned art and fine art keeps her painting skills in balance. One side paid the bills while the other satisfied her artistic creativity.

Being the type of artist that she is, Carol always liked the idea of being able to live wherever she and her husband wanted. That is why she happily shared that her home up in one of the more remote areas in Evergreen appeals so much to her. Our juror this year is Vladislav Yeliseyev.



Russian trained Vladislav Yeliseyev received his formal art education in 1977 and later earned his Master's Degree at The Moscow Institute of Architecture. Since then he moved to the United States and participated in numerous group and individual exhibitions. His unique ability to reflect transparency of natural light in his paintings and to accentuate the artistic qualities of the subject as juxtaposed with the natural environment quickly earned him a high reputation among the leading architects in the country. He painted thousands of watercolor illustrations for various commercial, residential and government projects such as Red Cross, Universities, Hospitals, etc. In 1992, Vladislav won the Formal Presentation Drawing Award from American Society of Architectural Illustrators. In 1993, his works were presented in group exhibition at Parsons School of Design and Vladislav was invited to teach a course of Architectural Illustration there in the following year. After receiving lots of inquires about his watercolor techniques, he released an

instructional DVD — watercolor workshop with Vladislav Yeliseyev "Painting Architecture".

Presently, Vladislav (Vlad) is practicing his art and conducting his architectural illustration business working on a wide range of projects with the clients from East to West coast from his own art studio in Sarasota, FL. Vlad is the owner of Vladislav Yeliseyev Architectural Illustration Company which he started in New York City in 1992 and now 20 years later, he founded Renaissance School of Art. The purpose of the school is to share his tremendous expertise with the professional community and to raise the skills of the young and amateur artists to the professional level.

Currently, Vladislav Yeliseyev is represented by Stakenborg Fine Art in Sarasota, Gallery Unique in Fort Myers and Collectors Gallery and Framery in Venice. His works can be found in private collections across the United States and Russia.

### The 26th Annual State Watercolor Exhibition

### Eligibility

Open to all artists, 18 years of age or older, residing in Colorado. CWS members who have moved out of state and maintained membership may enter.

### **Entry Requirements**

- Paintings must be predominantly watermedia (watercolor, acrylic, gouache, casein or tempera) on paper or synthetic paper, completed within the last two years (1/1/2015 to present), and not previously shown in a juried exhibit in Colorado. No canvas.
- Painting must be original and not copied from any copyrighted material or
  photographs, except those taken by the artist. No computer generated (digital)
  art will be accepted. Collage materials must be on papers painted by the artist.
  It is the artist's responsibility to receive permission for any likenesses used in
  any painting.
- The Artist's signature should appear on the front of the painting. CWS
  reserves the right to refuse any painting that does not comply with the
  requirements stated in the prospectus or does not match the submitted image. In
  case of question, the Chairperson's decision will be final.
- CWS reserves the right to reproduce images of accepted works for CD sales, publicity and educational use.
- Entry form must be completely filled out. Prices and all information on this
  entry form is considered final and may not be changed. No exceptions. Entries
  without signatures or completed notification cards will not be processed.
- All work displayed must remain for the duration of the exhibition.
- Any requirements of the exhibit not fulfilled will result in disqualification.
   Works juried into this exhibit and not delivered for exhibit will prohibit the artist's entry in CWS exhibitions for two years.

#### Presentation

Minimum image size: 8 x 10 inches. All works must be delivered framed and ready to hang. Framing must meet gallery quality standards. Frames must be suitable to the work and the exhibit, must be undamaged and reinforced with hardware and picture wire in place. No sawtooth hangers.

All works must be matted in clean white or off- white mats. No exceptions. Colored liners or fillets may not be larger than 1/4". ALL paintings must be under Plexiglas. Paintings delivered with chipped, cracked, damaged, dirty or improper presentation will be returned at the artist's expense. For a list of suggested mat colors, visit www.coloradowatercolorsociety.org.

### Digital Entries

One to three digital files may be submitted as an attachment to an email (be sure to mail in your entry form and supporting items) or on a CD enclosed with your entry form (CD's will not be returned). *Images must be jpeg format*, 1200 to 1920 pixels in the longest dimension, and 300 dpi.

IMPORTANT! To name your files: Use the first four (4) letters of your last name, the first four (4) letters of your first name, # of painting, shortened painting title: EiteSydn1Creation, EiteSydn2Curious

Write your name, address, phone, e-mail address, and image title(s) in the email or on the CD. Mail in your signed entry form and fees.
