#### February 2018

Two new signature members were approved, Diana Wade and Carol Barton

The Board has been recruited to help identify venues for our upcoming shows.

Greg Chapleski will jury the Scholastic Art Show along with Sharon Rouse. He has assembled a nice award packet with information on CWS for each winner. We will feature the award winners in the next newsletter. CWS donates \$500 in awards for this show.

Marcio Correa gave a report on the website and made several recommendations on how to manage this more effectively. We are looking for a new webmaster to take over this responsibility and Marcio will help train the new person.

#### March 20, 2018

We have \$500 in scholarship money. We are reviewing the Platteforum and Redlineart programs as potential candidates.

An inquiry was made by the Southern Colorado Watercolor Society to combine CWS and SCWS. The decision was made not to pursue this at this time.

Brian Serff has asked to be relieved of the job of publishing the monthly Collage. Options were discussed and it was decided that we could make this a paid position and go to a quarterly issue. Tim agreed to discuss this with Brian and see if that would work for the future.

Jay Breese discussed the statement in the prospectus that images might be published on a CD. This has never been done and it was decided to remove this from future prospectus.

For 2019, we will have the Members Show at the Lakewood Cultural Center.

For 2020, the Members Show will be at Lakewood Cultural Center and the State Show s scheduled for the Foothills Art Center in Golden.

#### April 20, 2018

Brian Serff has agreed to do a quarterly Collage beginning in May, 2018 for the compensation the Board and Brian agreed upon. Any announcements needed otherwise will be sent as e mail blasts to the members. Complete minutes of the meetings will be maintained on the website. All Board members are asked to review the Policies and Bylaws and send comments to him before the next meeting. Two policy changes we already need are: What information should be included in the new Quarterly Collage? Notebooks for Board Members

Shanthi will be taking over the web master position. There was a discussion about making this a board position. Two new Board members were introduced and will become official after the voting is complete:



### Western Fed News: From Tucson to San Diego

#### We are just back from Western Fed 43 in Tucson.

The 43rd Western Federation of Watercolor Societies conference and exhibition included as usual the opening and its awards ceremony, the delegate meetings, and hospitality events for both delegates and artists.

This year's conference took place on May 4 and 5, and was hosted by the Southern Arizona Watercolor Guild (SAWG) at the Radisson hotel in Tucson. Marcio Correa and Tim Brenner attended as CWS delegate and alternate, and Gene Youngmann and Janice Hanson were present as participating artists.



The Delegate meeting included review of the final report of last year's exhibition, presentation and discussion of the plans for next year's exhibition in San Diego, and other organizational and practical topics. The main decisions were to reinforce the mandate that at least one artist from each society is included in the exhibitions (this year, one society was not represented), and to invite other societies to join to fill in the existing

vacancy for a 12th member society.

In the afternoon, delegates and artists were taken on a tour of the Arizona Sonora Desert Museum—a beautiful combination of zoo and botanical gardens, with a maze of paths through desert gardens with cacti in bloom, well-designed wild animal enclosures and other informative displays. Our tour also included two art exhibitions: An international exhibition of wildlife artists, and an exhibit of watercolors by SAWG members. This was followed by a dinner to honor the participating and visiting artists—with beautiful panoramic views of saguaro punctuated desert hills in the sunset light.

Saturday started with the society networking meeting, where delegates and other participants

exchanged ideas and solutions for common challenges faced by the societies. Delegates also took a tour of one of Tucson's main art galleries owned by SAWG member Dianna Madaras, and then had a



few free hours to escape the 95 degree heat in the hotel pool or the air conditioned rooms.

The exhibition opening ceremony was late afternoon at the SAWG's own gallery. Delegates, artists and guests viewed the exhibit with admiration at the quality and variety of the artwork. The 100 paintings were hung in two rows along the walls and in central panels, grouped largely but by subject matter. Exhibition juror Ted Nuttall was present and very attentive to all artists for photos and conversation. Tim and I were very proud of our CWS artists in the show: Steve Ekblad, Pamela Hake, Janice Hanson, Lynn Nebergall, Judy Porzak, Lou Ann Sosalla, Anita Winter and Gene Youngmann.

The banguet and awards ceremony took place at another location. Project Manager Susan Morris thanked all contributors. volunteers and participants, and handed out the certificates to artist who achieved signature status. Ted Nuttall spoke of the joys and pains of choosing award winners, and then the 22 awards were announced by the exhibition manager. Best of show went to Bill Dale, of the Southwest Watercolor Society, for his figurative painting Deanna, and our own Pamela Hake received an Award of Merit for her abstract Redlands. Congratulations, Pam! Also congratulations and thanks to Susan and SAWG for putting together a great conference and exhibit.
