Brushes (types and sizes), paints (colors and their placement on the palette) the paper (brand, weight and size) – they should be in their proper places or not. Then the game plan is explained to the viewers and the creative genius, that every artist is gifted with, begins to show itself. All artists do it in some form or another. But, this time it is different. Instead of doing it ourselves, we will be watching a fellow watercolorist show you his way of doing things. On Tuesday, October, 21st, CWS's own Randy Hale will be giving a demo that will fill in all the blanks stated above. He has a very unique and colorful way of painting. He has given workshops to groups of all sizes and even individualized lessons. Randy's students always learn





something new because he tries to motivate others to think outside the box.

If you try something different... if you stretch your borders, you will be surprised at the outcome. That's how Randy has grown with his subjects and skills. His watercolor paintings strike an emotional chord that helps connect both himself and us to our past.

Randy grew up in Colorado as part of a family that raised horses. The work ethic of ranch life speaks to him as his paintings often reflect that western heritage. And, it also allows him to think beyond the traditional and into the abstract. Growth and change are an integral part of why his art often takes him into uncharted water... it's part of his process, his journey.

The Ice Cream social at the break was fantastic as usual, with everyone indulging in the obvious - ice cream - and, their favorite toppings.



When given an idea and a brush charged with watercolor, there is no telling what Brian Serff will come up with. This much is certain, whatever he paints, be it a portrait, still life or landscape, he pours his heart and soul into every artistic creation... they are a joy to behold!

But things weren't always this joyful for Brian. He grew up in London, England during WWII spending much of his energy into surviving bombing raids. After serving in the Royal Air Force in Scotland, he got a job the oldfashioned way, as an apprentice still life and lettering artist for a fine art printer in the city of London.


Fast forwarding to 1971, after being in the USA for six years, and having been bitten by the entrepreneurial spirit, he started his own graphic art business. It allowed him to buy a home and raise a family with his wife, Pat, at his side.

Being a multi-tasker at heart, the work-a-day world of Brian began to include becoming an accomplished watercolorist. He used his own photographs as resource material. He shot them himself while he traveled the world as a tourist, hiker, skier, river-runner and biker. Every activity he did came into play as he developed his skills in watercolor.

A dialog overheard on the field during the Bronco's game...

- Hey man, have you prepared your entries for the **40th Western** *Fed exhibit?* We are behind...
- No, not yet. There is plenty of time. We can go the length of the field in 59 seconds!
- Well, there is time, but the deadline of *November 15th, rushing fast! Don't get sacked.*
- I don't really know what to enter... So should we run, or pass?
- I would run it... Here's what you do: Choose your strongest water media piece, or a maximum of three pieces, done in the last two years (since Nov 15 2012), and which you have not shown in a national, international exhibit or online exhibit.
- Okay. I do have a piece with a white horse on orange and blue I like. And how do I enter?
- Here's what the coach told me: The prospectus is in the August 2014 Collage, you can get it from the CWS website. Read it well. You fill out the form, mail it with your entry fee and send your entry image. The image has to be a .jpg file, with resolution at 300 dpi, and the longest dimension set to 1200 pixels. Name your image with the CWS initials, first four letters of your last name, and the entry number and painting title, for example CWSmann1trophy.jpg...

- And do I throw it deep to Gene Youngmann as usual?
- Actually no, incomplete pass. Gene is no longer the CWS Delegate for the WFWS. You need to send it to the new Delegate: Marcio Correa, at 4742 Portofino Drive, Longmont CO 80503, marciocorrea@comcast.net. He's a rookie but learns fast.
- Can I register on the CWS website instead, and pay online? *Like betting on Vegas?*
- *Flag on the field...* Not this time, I'm afraid. Your options are to mail in your entry or bring it to Marcio at the CWS October meeting; and the payment is by *check made out to the Colorado Watercolor Society,* for \$35 for one entry, \$40 for two, or \$45 for three entries. *Just like we did in practice, that's all.*
- Wow, thank you for your help! Caught it. Touchdown!
- Don't mention it. Just do not miss the deadline, and best of luck! *See you at the post game interviews...*

The following are the highlights from the last CWS Board meeting held September 16, 2014.

CWS currently has 435 members, 69 of whom are new members.

Each month a different CWS member will create and pass out an artist bio as well as show examples of their work, explaining the materials they use and their process of creating art.

Each CWS meeting attendees will be asked to sign a form showing their county of residence. The forms will be used to validate attendance for SCFD funding.

Meeting attendees are asked to put ideas in a new suggestion box. Complaints should be verbally made to President, Greg Chapleski.

Randy Hale will demonstrate his painting techniques in October.

The New Trends show will be held at the Point Gallery December 2 - 20. The reception will be Saturday evening, the 6th.

The 2014-2015 Membership Roster will be out in October.

A committee is being formed to find a permanent CWS meeting/ workshop/gallery site.

Every CWS workshop has had full attendance. Pat Pucker's current workshop will meet weekly through October 16. The upcoming Tom Jones workshop will round out the 2014 workshop offerings.

Entry Requirements

• Entries are strongly encouraged to be your best "New Trends" work both in subject matter and techniques. Think outside the box. Try something different. Keep in mind that this is being held at a "contemporary" art gallery in the Santa Fe Arts District.

 Entries must be predominantly water media. Collage and other materials may be incorporated. Grounds can be on yupo, canvas, illustration and scratch board, glass or any paper.

 Work must be completed in the last two years and not previously shown in a juried CWS or WFWS show.

 The Artist's signature should appear on the front of the painting.
 CWS reserves the right to refuse any painting that does not comply with the requirements stated in the prospectus or does not match the submitted image. In case of question, the Chairperson's decision will be final.

 CWS reserves the right to reproduce images of accepted works for CD sales, publicity and educational use.

This prospectus may be copied for interested artists.

Entry form must be completely filled out. Prices and all information on this
entry form is considered final and may not be changed. No exceptions. Entries
without signatures or completed notification cards will not be processed.

 All work displayed must remain for the duration of the exhibition.
 It is the artist's responsibility to receive permission for any likenesses used in any painting.

Any requirements of the exhibit not fulfilled will result in disqualification.
 Works juried into this exhibit and not delivered for exhibit will prohibit the artist's entry in CWS exhibitions for two years.

Eligibility

Open to all CWS members whose dues are current. CWS members who have moved out of state, and maintained membership may enter.

Presentation

All works must be delivered framed and ready to hang. Framing must meet gallery quality standards. Frames must be suitable to the work and the exhibit, must be undamaged and reinforced with hardware and picture wire (with taped ends) in place. No sawtooth hangers. Matted works must be matted in white matts. Colored liners or fillets may not be larger than 1/4". Glazed paintings must be under Plexiglas - no glass. Minimum image size must be 8 x 10 inches. Paintings delivered with chipped, cracked, damaged, dirty or improper presentation will be returned at the artist's expense. Sales of Art Work

All artwork MUST BE FOR SALE. There will be a 30% commission on all sales. Bin Work

Each artist who enters this show (not just those accepted) will be allowed to put 3 pieces of bin work in the show. Maximum size of longest dimension is 24". All work must be shrink wrapped or placed in a clear bag. Each piece must be labeled on back with your name, title of work, contact information and price.

Digital Entries

Images must be jpeg format, 1920 pixels in the longest dimension, and 300 dpi.

One to three digital files may be submitted as an attachment to an e-mail (be sure to mail in your entry form and supporting items) or on a CD enclosed with your entry form (CD's will not be returned).

To name your files: Use the first four (4) letters of your last name, the first four (4) letters of your first name, # of painting, shortened painting title: EiteSydn1Creation, EiteSydn2Curious

Write your name, address, phone, e-mail address, and image title(s) in the e-mail or on the CD. Mail in your signed entry form and fees.


