





CWS Board in Brief: June 2019

Because the May meeting was canceled due to weather, and there is no July meeting, this will be the only Board in Brief for this edition.

June 25, 2019

New Board members are: Pattie Bowler, President Elect; Kathy Cranmer, Exhibits Chairman; and Suszanne Bernat Droney, Recording Secretary.

Planning Board meeting scheduled for August 21 at 5:00 pm.

Sterling Edwards will hold a four-day workshop at First Plymouth Congregational Church.

CWS will provide a \$150 reciprocal award to the Pikes Peak Watercolor Society for their shows.

The budget for the WFWS delegates was discussed. A motion was made and seconded to reimburse delegate invoices, one delegate and one alternative, as submitted for now. Priscilla Greenbaum agreed to present a proposal based on her research of WFWS reimbursements and present it to the next Board meeting for a final decision on the matter.

Jackie Kingsbury, Curt Gillespie and Mary Schaefer Benke have met the requirements for CWS Signature Member status. Upon motion made and seconded the Board voted to accept these three as Signature Members.

Tim Brenner, Chair of the 2019 Members Show, reported the show runs from November 15, 2019 to January 3, 2020. The reception, November 22, will be provided by Lakewood Cultural Center. The forthcoming prospectus will be posted on the CWS website.

Diane Fechenbach, Recognition Committee, recommends Vicki Tucker, former member, to receive recognition for her contributions to CWS. The committee is in need for a name(s) of candidates for an upcoming recognition.

It was agreed by the Board that those accepted into Splash of Colorado 2019 may have their painting(s) delivered to the show in Crested Butte and returned to Denver for a \$25 fee. Tim Brenner will deliver the paintings to the show site and Mary Jo Ramsdale will bring them back.

The three-day Plein Air paint-out at the Chatfield Botanical Gardens held this month was well attended by approximately 70 artists. The Gardens administration would like this event to return. Gene Youngmann agreed to take chairmanship again with the expectation of mentoring the next chair, aiming for this Fall, sometime in September.

Priscilla Greenbaum gave the Treasurer's Report. The book-keeper filed our annual CWS update with the Colorado Secretary of State. Priscilla noted in her three-month printout that we may go "over budget" this year due to a \$500 insurance payment, the reimbursements to the WFWS delegates and normal operating expenses. Regarding the WFWS delegates, she expressed support for reimbursing the two delegates the actual expenses this year. She also suggested revisiting the amount of future CWS State Exhibit awards in the By-laws. There is also a question of the Rocky Mountain Watercolor Society donation that needs to be considered.

Sandy Day Selbert provided a report on workshops. Peggy Morgan Stenmark will present a workshop in August 2019 in Crested Butte. There will be an opening reception at the Gunnison Art Center. Sandy presented questions from Karen Hill, Chairman of Splash of Colorado, who was unable to attend the meeting.

Shanthi Kumar reported that the CWS website is going well despite various emails she receives. She requested some photos of the Plein Air paintout be given to her in order to post them on the CWS Facebook page. Gene Youngmann agreed to send them to her.

GENERAL MEETING

Diane Fechenbach presented Vicki Tucker's name to the membership at the general meeting for recognition of her past service to CWS.

The upcoming WFWS 45th exhibit will be held in Boise, Idaho, beginning June 4 through July 26, 2020. The deadline for entry is December 10, 2019 and the prospectus will be uploaded to the CWS website as soon as available.

Beatrice Trautman announced the idea of a "pizza" party for the September meeting.

Gene Youngmann reported on the success of the Chatfield Botanical Gardens paint-out. He presented a slide show of some of the participants.

Sandy Day Selbert announced the Crested Butte workshop on August 3rd with artist Peggy Morgan Stenmark as presenter of "mountain landscapes."

Due to inclement weather in May, the Board election was pushed back to this month, June. Carol Newsom presented the 2019-20 slate of candidates for the new board. Linden Kirby made a motion to accept the slate and Gene Youngmann seconded it. Jay Breese, Parliamentarian, had already received 120 votes by email in favor of the slate. 28 of those present at the meeting then also voted in favor of the slate, so the new Board was approved unanimously.

The meeting was adjourned and current CWS member and artist Pat Fostvedt conducted a critique for all members who brought a painting.

Darcie Kurtak Loves Power of the Unexpected

From a very small studio that doubles as her office, Darcie Kurtak creates abstract nature scenes filled with textures and impressions that surprise and inspire her.

After a 30-year career with a law firm and 6-year journey of watercolor discovery, Darcie is very honored to be one of the newest CWS signature members. While there are several artists in her family (both amateur and professional), she is without any degree in art. Her learning has been primarily from classes, workshops and some on-line study.

The first painting accepted into a CWS juried show was "Cattails," and it is typical of her style, influenced by Ann Blockley. "I love to put several different colors of very wet paint on paper with pieces of grass, fluff

and seeds. I cover them with plastic wrap, weight them with books, and let it all dry." Then, "I figure out what the painting wants to be." There is a power in watercolor's "unexpectedness" that Darcie has learned to tap in to. "I start out thinking I'm doing one thing and it turns out totally different."

Even Darcie's discovery of watercolor itself was unexpected. A few years ago, she accepted a spiritual challenge to perform an "Act of Power." In response, she decided to take art lessons. She started looking for oil or acrylic painting lessons, but what she found instead was a beginning watercolor class. Within 2 weeks she was immersed in watercolor and "I fell in love with the medium and plan to continue learning and painting the rest of my life!"

Curt Gillespie Pre-Plans for Balance



"Watercolor is a surreal mistress. Its immediacy is intoxicating, but oh! what a challenging medium." That is how Curt Gillespie, one of the newest CWS signature members expresses his feeling about watercolor on his website. So how does he deal with the challenges?

Pre-planning. "I dislike . . . so much pre-planning to save the whites. Can't just dive in. It's constricting. But once I have the painting's plan down, I'm free to let it flow!" After Curt has decided that watercolor is the right medium for his subject, he starts the planning process with thumbnail drawings to make sure the composition and values are right. He invests time in visually creating the painting step-by-step. A good drawing in basic. Mask the whites. Lay down rich, luscious color and let it flow. Then build the painting, relayering color as needed and adding details bit by bit. "The juxtaposition of visual texture, detail and resting areas in the right proportion is what I strive for."

Curt is fortunate to have two studios. One is at his gallery, Greenstone Artworks in Westcliffe, CO, which he uses primarily for oil paintings.

His home studio is dedicated mostly to watercolors which may be started in the field but finished in the studio. Curt's life is very full, but having two studios



Achieving signature status with CWS has been a goal for some time, Curt says. "I feel great about it! I'm no better than anyone else, really. My work hasn't really blossomed into what my mind's eye wants to do. Now the real work comes . . . time to get even better, keep the pressure on myself to excel."

Mary Benke's love for art began in high school, and while earning degrees in journalism and English at the University of Southern California, she also studied painting and drawing. Mary worked as a magazine editor and graphic designer until 2003. After retiring "I rediscovered fine art through watercolor and pastel classes and workshops, and I continue to paint every chance I get." Her dedication to painting has now led her to achieving signature status with CWS.

"I rely on my graphic design background to bring a strong sense of imagery to my paintings," Mary says. "The unique use of line and texture is a consistent element throughout my paintings." While she is "drawn to the luminosity of watercolor. I also enjoy combining my favorite media and doing collage and mixed media work."

Mary finds her subjects everywhere. The Colorado outdoors provides an

IN MEMORIAM

Broadcaster Became Artist

Roell Custer

Noell Custer (born May 26, 1939), a well-known Denver broadcaster and CWS watercolor artist, passed away February 12, 2019. In a phone interview, her husband Ken told of her life and interest in art.

"Noell always wanted to be an artist," Ken said, "but her 'Noell and Andy Show' on KLZ-TV [now KMGH, Channel 7] was so successful she couldn't leave it for 15 years." In Noell's own words, "I realized that I was way too comfortable doing [my broadcasting work] and if I was ever going to be an artist, it was time to get out. So, I did." In the early 1980s she joined the Colorado Watercolor Society and served as show chairman for "two or three years" and also gained CWS signature status. In addition, Noell was a member of the Arvada Art Guild and the Painted Toes Art Guild.

Noell experimented with oil painting, but always returned to watercolor "because I love it!" She not only enjoyed the art itself but the art community and the people who became her friends. Noell's career in TV led to her induction into the 2013 Broadcast Professionals Hall of Fame, an honor she was proud of, but she also could count herself as a successful artist and a friend to many.

Eligibility

This exhibit is open to all CWS members whose dues are paid.

Entry Requirements

- Painting must be predominantly watermedia (watercolor, acrylic, gouache, casein and tempera) on paper or yupo.
 Painting must have been completed within the last two years (2017-present), and not previously shown in a juried Colorado Watercolor Society exhibit.
- Painting must be original and not copied from any copyrighted material or photographs, except those taken by the artist.
 It is the artist's responsibility to receive permission for any likenesses used in any painting. No computer generated (digital) art will be accepted. Collage materials must be on papers painted by the artist.
- The Artist's signature should appear on the front of the painting.
- CWS reserves the right to reproduce images of accepted works for publicity and educational use.
- This prospectus may be copied for member artists.
- Entry form must be completely filled out. Prices and all information on this entry form is considered final and may not be changed. No exceptions. Entries without signatures will not be processed.
- All work displayed must remain for the duration of the exhibition.
- Any requirements of the exhibit not fulfilled will result in disqualification. Works entered into this exhibit and not delivered for exhibit will prohibit the artist's entry in CWS exhibitions for two years.

Presentation/framing:

Maximum image size: 18" x 24". Minimum image size: 8" x 10"

- All works must be delivered framed and ready to hang. Framing
 must meet gallery quality standards. Frames must be suitable
 to the work and the exhibit, must be undamaged and reinforced
 with hardware and picture wire in place. No sawtooth hangers.
- All works must be matted in clean white or off-white mats.
 No exceptions. Colored liners or fillets may not be larger than 1/4". For a list of suggested white mat colors, visit www.coloradowatercolorsociety.org.
- Paintings can be glazed with glass or plexiglas but no unglazed paintings will be accepted. Paintings delivered with chipped, cracked, damaged, dirty or improper presentation will be returned at the artist's expense.

Sales of Art Work

There will be a 30% commission on all sales of artwork.

Liability

Utmost care will be taken in handling paintings, however the Colorado Watercolor Society and Lakewood Cultural Center will not be responsible for any damage to any art or image submitted to the exhibition. Insurance is the artist's responsibility.
